


- No matter S1 and S2 are connected or left idle to the external switch, this device can be controlled by automation or the App.
 - It is prohibited to connect S1 and S2 terminals to the neutral or ground wire, in order to avoid damaging the equipment and causing danger.
 - Make sure all wires are connected correctly.

3. Power on

After powering on, the device will enter the Pairing Mode defaulted during the first use, and the Network indicator flashes in a cycle of two short and one long.
